- 4. Buyer on delivery, is responsible for inspection of quantity, size, type, quality and shipping damage. Any claims must be relayed to Steel Sales, Inc. within (10) days of delivery.
- 5. Unless the Buyer has a current signed Tax Exempt Certificate on file with the Seller, the Buyer is responsible for all applicable Sales Tax at the time of delivery.
